# WELCOME TO THE COURSE OF YOUR LIFE

The year of study at Azad University (IR) in Oxford, one of the most famous academic cities globally and near London is very effective for discovering new opportunities, new friends and new horizons. But more importantly, in this one year, you will learn how to think critically and theorise your findings. A step that can change your life and possibly you never forget it.

As a short course in Executive Public Policy, it has gained experience in the heart of the scientific and international community

### Why is the executive policy course designed for policymakers? Public Policy Course for Policymakers: Linking Theory and Practice

- Public policy professors at universities and training centres teach "public policy" and "policy analysis" to undergraduate and doctoral students. Observing the employment of public policy students in Central and Southwest Asia including Persian-speaking countries shows that graduates of this field rarely enter political positions in governments as policymakers or policy analysts. Few of these students become lecturers themselves and teach other students. They still do not have real experience in policymaking, and this vicious cycle continues.
- On the other hand, policymakers and public politicians are often deprived of the knowledge of policymaking and policy analysis. They are not trained for such a vital mission. Their practical experiences have no theoretical support, and their practical experiences do not enrich the policy sciences. The current course of public executive policy was designed to fill this gap between policy knowledge and policymakers, first developed in 2008 to train public policymakers.
- I was interested in conducting this course in developing countries by training the country's top policymakers. My further studies of public policy in Southwest Asia have shown that most of these problems and resistance to education are due to the weakness of the public sphere in these countries.
- During my return to Iran in 2018, we created an internship for PhD students in health policy at the Secretariat of the Supreme Council for Health and Food Security to familiarise students at the School of Health of Tehran University of Medical Sciences with the realities of policymaking.
- The Corona pandemic has shown how much policymakers in developing countries need public policy training. This need led us to redesign the executive policy course to improve policy knowledge and new experiences. Fortunately, today this 9-month program (three quarterly courses) has been prepared with the priority of Persianspeaking countries to train policymakers in real policy environments.
- The offer of this course was welcomed by universities and institutes of education and research inside and outside the country - including UNESCO, Islamic Azad University, Allameh Tabatabai University, Sharif University of Technology, Afghan Academy of Sciences. In this course, several domestic and foreign professors teach theoretical principles and case studies of policy and transfer global experiences.
- The method of this course is unique in the world. In addition to theoretical training, policy cases (real cases) are presented in the form of a policy lab by senior politicians and policymakers, and participants are involved in role-playing meetings. Leading policy analysts are simultaneously analyzing these policy questions.
- Public policy knowledge is interdisciplinary and inter-sectoral knowledge. The course will use a wide range of sciences from biology and neuroscience to social, political and economic sciences. In addition to teaching the basics and theories of policy, many studies in international relations, foreign policy, education policy, economic policy, mass media, environmental policy, health and social welfare policy and development policy Will be analyzed.
- First Trimester (EPPC) The beginning of a 9-month training course called EPPPC (which will continue with the second phase (EPPD) and the third (advanced) EPPM.
- We hope to fully implement this educational program with the help of professors and academic and research centres in the member countries, which can play a significant role in creating a cultural atmosphere in Persianspeaking countries.







#### **Teaching Methods**

In each of the three modules you spend on each of the quarterly bundles, teaching will include a combination of lectures and case analysis, evidence review, theoretical analysis, and group work and presentations, depending on the case and simultaneously.

A number of lectures given by politicians and policymakers as case reports are strongly recommended. However, classes are mandatory and you are usually expected to submit three written assignments or a set number of problems per course (one for each module) in each semester.





The taught elements of our courses, both theoretical and case studies, are intended as a framework only, enabling you to provide a framework for further research and study. In addition to "formal" class time, we expect our students to spend at least twice as much "independent" study time on their modules. Tabulated teaching may be just a few hours a week, but reading and writing and further study should accompany it.

Articles, projects and other periodic assignments make up a full working week. Remember, personal motivation and work commitment are the key to success!

#### Pre-test and Post-test


For most courses, participants are assessed by a pre-test and post-test, and writing an assignment, notably those taught by visiting professors, have post-test on basis of their style of assessment. Post-course test usually take the form of a two-hour unseen paper, and all Course participants are required to take the test. Typically, this usually consists of an independently produced piece of writing.

#### Importance and Necessity: Filling the Gap

As mentioned in the statement, today the hypothetical wall between sciences and especially between humanities has collapsed and human problems are studied, studied and resolved in a consensual and interdisciplinary framework. On the other hand, an attempt is made to create an organic connection between theoretical issues on the one hand and the realities of the implementation and practice environment on the other hand, and to replace one-dimensional views in policy-making, management and administration of societies with a multi-dimensional view. In our society today, especially in developing countries, the gap between the field of thought and practice is a fundamental issue, and there is a significant gap between university education and its application in society.

It can be said conclusively that the university graduates, unfortunately, are not ready to apply their knowledge in practice, so they must take a scientific and practical course to get acquainted with the environment and how to deal with its threats and make the right decision. Therefore, it is necessary for those who are active in the field of practice to gain this familiarity. For this reason, although currently a handful of universities in Persian-speaking countries train students in the field of policy-making, but typically these students are not in policy-making positions, nor the type of training they can meet the needs of policy-making in real fields, and thirdly The majority of the country's policymakers do not have access to these formal and thermal university trainings. That is why this course is designed to fill this gap.

# The second level of Executive Public Policy - Training course for policy makers: EPPD

The second level of executive policy-making training for policymakers continues with separate registration and the presentation of three supplementary modules.

This course will include a 4-hour one-day workshop on how to write a policy report.



### The Third level of Executive Public Policy training course for policy makers: EPPM

The third level of Executive Public Policy training course for policymakers continues with separate registration and the presentation of three supplementary modules. Participants in this course must have completed all three modules of the first level

course and three modules of the second course and have received the first level certificate and the diploma of the second course.

Each module is presented in 4 weeks (12 sessions of 60 minutes of training), and the whole course will last 12 weeks.

This course will include 4-hour one-day computer analysis of policy data.

The OICC has come to understand that all successes and failures at the national and global levels are entirely related to the speed and quality of decision and policy. Policymaking requires special knowledge and skills that cannot be achieved without training. Policymakers and senior executives are the most essential target population that must be trained to lead the policy-making cycle or implement or evaluate policies. Having these skills is necessary for analyzing public policies. Also, a policymaker must understand political interactions, be aware of the mechanism and role of power in politics, know how to reflect on politics, make political connections, and persuade.


